II. QUORUM

The meeting started at 3:00 PM AST. A quorum was established with four Trustees present.

III. OVERVIEW OF PORTFOLIO PERFORMANCE

Rhett Humphreys discussed PRT's portfolio's performance, the market's fluctuations, and certain trades. He informed that as of March 18, 2025, the portfolio's fiscal year-to-date return was approximately 5.6%.

IV. INVESTMENT MANAGER RFP

Counsel Semma Arzapalo provided an update on the negotiations for selection of a third investment manager and discussed legal issues that may affect the Trust's ability to contract with certain investment managers. The Trustees requested to be updated on any future developments.

V. ASSET AND WITHDRAWAL MANAGEMENT MODELING STUDY

María del Carmen López provided an update on the draft RFP. The comments from Trustees were incorporated in the RFP and the final version will be shared before issuance.

VI. ANNUAL REPORT

Mrs. López stated that the annual report draft was circulated to the Trustees. The Trustees will review the contents thereof and will provide feedback.

VII. JUNE MEETING

Trustee Fichtner stated that the meetings with the Act 106 Board and PBC will be held in June on the same day. Mrs. López informed that the meeting with PBC will be in the morning and the meeting with the Act 106 Board will be in the afternoon.

VIII. ANNUAL COMPLIANCE AUDIT

Julian Bayne stated that the amended *Guidelines for the Governance and Administration of the Puerto Rico Plan of Adjustment Pension Reserve Trust and Monitoring of Plan of Adjustment Pension Benefits* require that PRT, PBC and the government establish agreed-upon procedures for an annual compliance audit by June 9, 2025. He provided the status of PRT's efforts to timely comply with such requirement.
